*Description of Relationship to First Generation _____

Eligibility for new membership in the CLUB shall be limited to owners who are natural persons (not business or corporate entity) of single-family dwellings, and owners of commercial buildings and that said dwelling or building shall be located within the legal boundaries of the City of Victor and surrounding areas that include Goldfield, Lawrence, Hollywood, Cunningham and Sunny Side, that are served by the City's water system and currently paying monthly fees, therefor. Club membership shall be limited to a maximum of two members per property address, both names, and only those names, must appear on the records of the Teller County Assessor's Office as owners of the property; married couple shall be considered one member and/or name. Membership in the CLUB may include beneficiaries of a Family Trust or LLC that own a single-family dwelling or a commercial building as outlined above; provided that the Family Trust or LLC has a maximum of two beneficiaries/owners per parcel of property and only those two beneficiaries/owners shall be permitted to be members in the CLUB. Tenant residents, which have proof of a 5 Year Lease within the boundaries of City of Victor and surrounding areas listed above, can apply. Legacy (Second generation) are eligible to join the club, if they reside within the RE-1 School District boundaries and the current first-generation club member are in good standing. As of February 9, 2012 (March 16, 2023), when a member sells or moves out of the associated properties listed, will lose their membership in the fishing club. A limited number of Legacy and Tenant applicants will be reviewed and processed through the GCFC board and City of Victor decision per current lease agreement.

Include a copy of your deed and water bill with your application. Application fee of (\$150), a new key fee (\$6) and annual dues (\$100) are payable upon approval of membership. Please do not include payment with this application.
